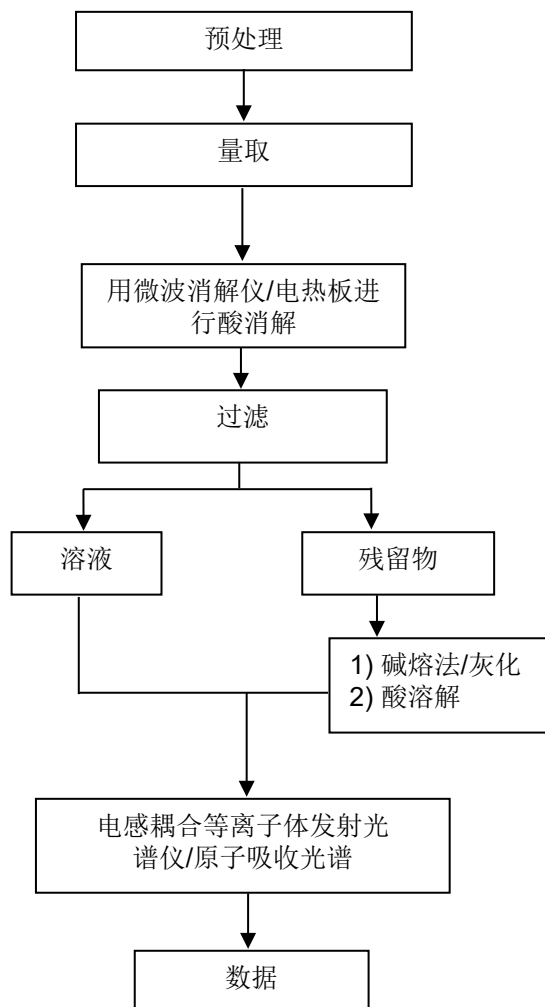

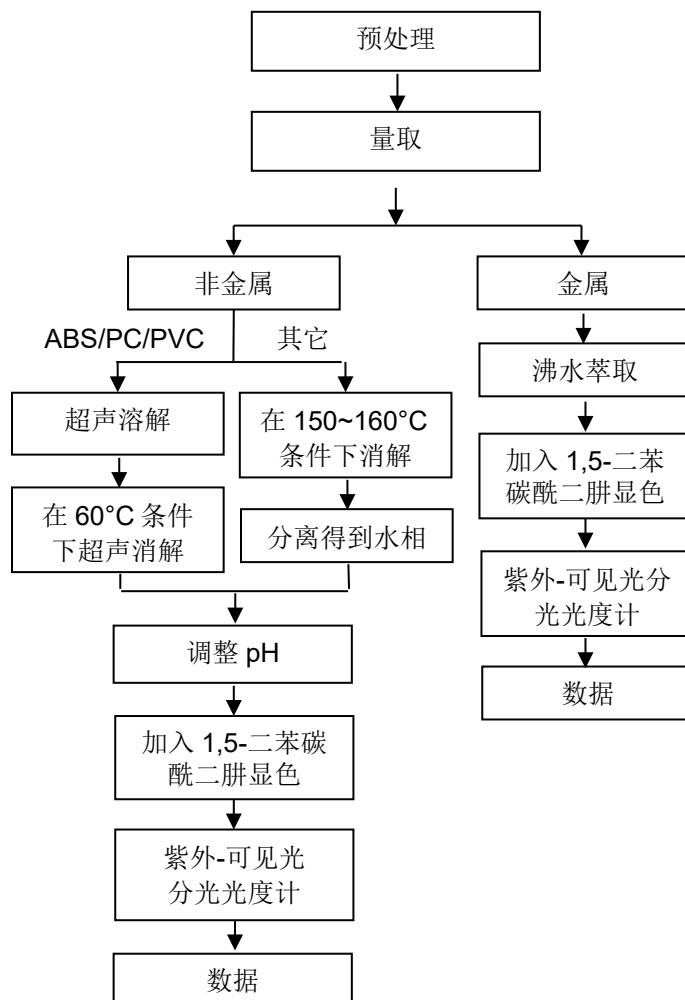

元素检测流程图

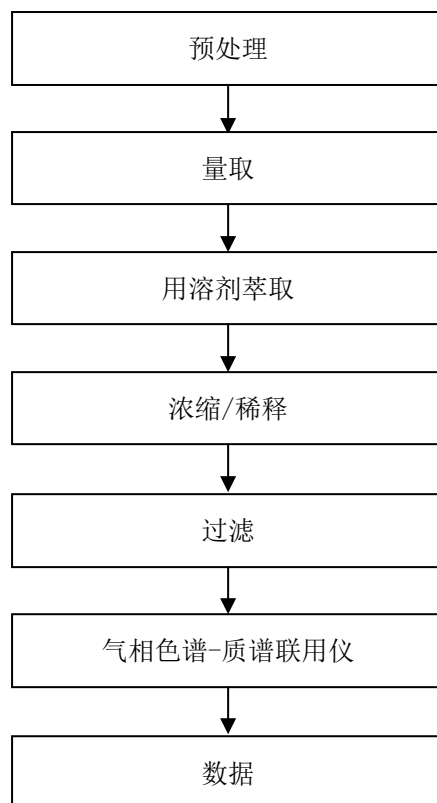

PBB(s)/PBDE(s)/Phthalates 检测流程图



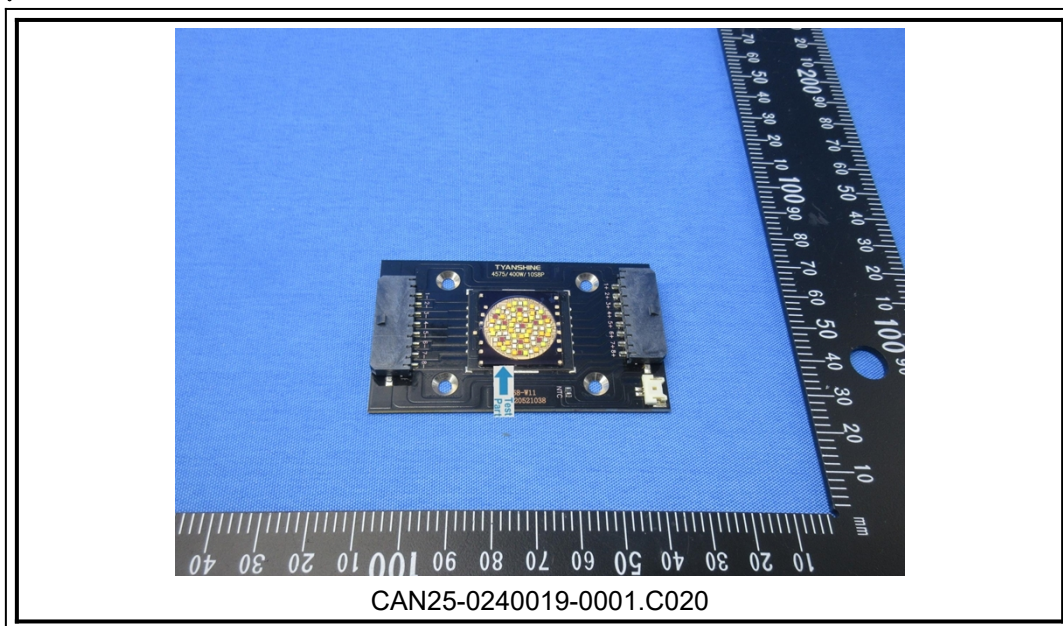
